## Position: Information Assurance Engineer\_Falls Church

**Location/Department:** Falls Church, VA / Services

**Qualifications or Skill Required:** TAG is seeking a cleared Information Assurance Engineer - Senior for our site in Columbus, OH. Under general direction, the candidate is responsible for all activities relating to information assurance procedures and systems. Develops information systems assurance programs and control guidelines. Confers with and advises subordinates on administrative policies and procedures and resolving technical problems, priorities, and methods. Consults with and advises other sections regarding internal controls and security procedures. Prepares activity and progress reports relating to the information systems audit function.

**Responsibilities:** Perform security management and administration tasks for operational (production site) managed Services Oriented Architecture (SOA)-based services. Administer and operate enterprise security systems including network and host intrusion detection systems, security compliance system, security audit log management system, anti-virus protection system, security scanning and remediation tools, and others. These may include McAfee, SourceFire, LogLogic, and other security products. Accomplish security monitoring and incident handling in accordance with established procedures. Develop, implement, and enforce security procedures, contingency plans, incident handling reporting plans, and other security documentation necessary to ensure protection of the managed SOA-based services. Perform Information Assurance assessments regularly, implement security technical configuration guidelines (STIG) mostly for Solaris 10 platforms, and apply DoD Security Readiness Review (SRR) scripts periodically to check for STIG compliance. In coordination with network/system administrators of the SOA-based managed services, execute security test plans, document results, and implement required resolution of findings. Work with network/system administrators to ensure compliance with IA controls including proper account and password/credential management, DoD Ports, Protocols, and Services (PPS) guidance, and others. Coordinate with the designated Computer Network Defense Service Provider (CNDSP) to accomplish security monitoring and reporting. Support the DoD Security Certification and Accreditation Process to ensure the attainment of Security Accreditation and DoD Network Connection Approval. Ensure compliance with DoD Information Assurance Controls and FISMA requirements and report on compliance. Perform as Information Assurance Officer (IAO)/Information Systems Security Officer (ISSO).

### Essential Job Functions:

- Performs moderately complex security systems modeling, simulation, and analysis to provide appropriate solution.
- Develops and oversees security software system testing procedures, programming, and documentation to ensure standard use of procedures.
- Provides inputs for documentation of new or existing security system procedures and/or programs to ensure information accessibility, as required.
- Designs, develops, troubleshoots and analyzes software programs to ensure compatibility with hardware systems.
- Customizes security system software based on research and customer needs as appropriate.
- Coordinates and facilitates communications with other departments and/or commercial vendors) to investigate and resolve security vulnerability matters of significance and to ensure proper functioning of security systems.
- Maintains communication with management and customers regarding status of security system procedures, processes and software development and problems.
- Acts as technical lead on large projects involving a particular security system initiative or counter measure.

- Provides leadership and work guidance to less experienced personnel.
- Provides the customer base with first level support.
- Documents security equipment scaling plans and limitations.
- Develops detailed design using best of breed security equipment including firewalls, intrusion detection systems (IDS), and access control servers.
- Experience working with UNIX and SUN Operating Systems, Storage and backup, Visio Drawing tool, Cisco Works/Hardware, Crystal Reports, McAfee Antivirus, and SourceFire
